**06/00183/FUL Erection of swimming pool/conservatory extension at 1 Holly Lane Tansley – no objections**

**06/00275/out Erection of storage building (outline) at Sunnyside Farm, Whitelea Lane Tansley – Object as follows:-**

1. There is no scope for visibility splays onto Whitelea Lane making access/egress dangerous
2. increased volume of traffic created on country lanes or within the village, creating an additional danger to people, children at the post office where the buses turn round
3. the visual impact on the rural landscape
4. the site is entirely inappropriate for any industrial development, there is plenty of availability within established industrial sites within the village ie. Brookfield/Drabbles Mill

- 5. There will be environmental noise impact
- 6. The extra industrial development could lead to light pollution
