**112.2011.1 PUBLIC SPEAKING**

Questions were asked once again from a resident about the sum of money spent on the Fete Field. The resident did say that the Parish Council could perhaps sell the Fete Field for a nominal sum (£1), which would solve the problem. Could a mowing machine be purchased and then all users could carry out the mowing of the field.

The Chair informed the meeting that there have been concerns about the sums of money, although this has been a one off payment, and the Parish Council are in the process of finalising the agreement with the Management Committee. The Football Club are tenants of the Fete Field Management Committee. The Parish Council arrange for the mowing and pay this, but do currently get reimbursed from DDDC.

The resident thanked the parish council for their time and left the meeting.

## **115/2011 FETE FIELD**

### **115.2011.1 Proposed Management Agreement**

The clerk has now amended the agreement in line with changes agreed. The basis of the agreement was originally put together by the Parish Council's solicitors.

The Parish Council needs to come to an agreement on the figure to be allocated to the Fete Field, this needs to be finalised at the January meeting.

#### **RESOLVED:**

That Cllr Gray would approach C Gale; Solicitor to look over the nearly finalised agreement before signing, if he is unable to do this, then another solicitor would be approached.

### **115.2011.2 Post Box/Noticeboard at The Pavilion**

There was some concern about the 'post' for the Fete Field, as items had been re-directed to the clerk in a round about way. A noticeboard might also be suitable for publishing contact details for the property and also for publishing fixtures etc. After discussion it was felt that a post box might be mis-used, but the Fete Field Committee need to ensure that all correspondence is addressed correctly to avoid any delays.

#### **RESOLVED:**

Not to erect a post box at this time, but to erect a noticeboard at the end of the building. Cllr Taylor would arrange this.

### **118/2011 CONSERVATION WORK**

**118.2011.1 Spout Lane** – the work has not yet been carried out due to the bad weather, permission has been received to prune the self sets on Spout Lane.

**118.2011.2 Fete Field Bund Area** – this area will be tidied up also, but there could be a problem with an overhanging tree, this may need to be pruned.

**119/2011 TANSLEY HOUSE MINI BUS**

A request for help with funding was received last year, an amount was not stipulated.

**RESOLVED:**

To send a response – informing them that due to private business unable to help with funding this project. The Parish Council would like to be kept informed of progress as may be able to support in some way in the future.

**120/2011 PARISH COUNCIL DOMAIN NAME RENEWAL**

Currently the renewal is sent to a resident no longer on the parish council, this is up for renewal in June of 2011, cost for 2 years is £24.99 + vat; 5 years is £55.96 + vat.

The web site is very much improved and thanks must go to Chris Knightley for this.

**RESOLVED:**

That the renewal be set up in the Clerk's name, and that it is renewed for 5 years.

**121/2011 CLERK'S OFFICE ARRANGEMENTS – VILLAGE HALL**

Storage of equipment can be arranged in the back room at the village hall, there is adequate space, the hourly rate when actually used would be £4/hour, usage could be around 4 hours per month.

**RESOLVED:**

That arrangements are made for the clerk to move files etc., in after the new year.

**122/2011 CORRESPONDENCE & CIRCULARS**

Were noted, the winter weather information was very good, to put this in the noticeboards.

**123/2011 PARISH COUNCIL UPDATES**

**123.2011.1 DDDC Home Options – West Yard Local Letting Plan**

The chair explained that there had also been a request from Peak District Rural Housing Association to discuss the allocation of the properties on West Yard. DDDC were putting together a 'local letting plan' as per letter of October. There seems to be confusion as to what is happening with this.

**RESOLVED:**

The Chair would try and get a meeting arranged with Rob Cogings; DDDC early in the new year.

**123.2011.2** Headstone Strips in Burial Ground

The Parish Council are still disappointed with this work. Need to meet with contractor on site to discuss.

Cllr Taylor and Cllr Strange would deal with this.

**123.2011.3** West Yard surfacing and street lighting

Thatchers Croft will be adopted and have street lighting up to the flats, the rest does seem to be going to be adopted.

**123.2011.4** Hand Rail at the Knoll

To be progress chased.

**123.2011.5** Riber View Close – planting

The licence to cultivate has been sent to residents.

**123.2011.6** Riber View Close – litter/dog poo bins

When the Clerk and the Chair visited Riber View, residents came out and discussed the siting of the above, this could not be agreed upon, and residents would come back with suitable sites.

**RESOLVED:**

To defer until residents come back to the parish council with definite sites for the above.

**123.2011.7** Enforcement at Nottingham Road (change of levels) and Knabb Hall Lane (static caravan).

The clerk has sent plans of both problems to DDDC

**123.2011.8** Movement of Dog Bin from Fete Field to Thatchers Lane

**RESOLVED:**

To site this near to the Grit Bin on Thatchers Lane, near to Daisy Bank.

**123.2011.9** Grit Bin Provision

Information received from DCC is that it will cost the Parish Council £70 to fill a grit bin after the initial provision. This could amount to a considerable amount per year. Contracts would have to be entered into for the regular filling.

**RESOLVED:**

To write to DCC and request that they put 'piles' of grit on White Lea Lane for use by motorists.

**123.2011.10** Overhanging trees – Thatchers Lane to Alders Lane/White Lea Lane
