111.2010.1 PUBLIC SPEAKING

Drainage gullies are unable to 'run' properly already, these have been a problem for 43 years, so can only get worse. Houses at the bottom of Church Street are still having problems with the flooding.

114/2010 FETE FIELD AND FOOTBALL CLUB A PRESENTATION BY STEVE CHAPMAN

Steve Chapman thanked the Parish Council for the opportunity to put forward an overview of the football club.

The Football Club was formed 14 years ago, by Steve Chapman and Ralph Emerson, with 1 x 7 a side team, now over 150 youngsters involved with about 1/3 of these from Tansley, this season an adult team also. Almost every team needs outsiders to make up the numbers for the age groups. The club has taken on children from foster parents, children in care, etc., The club reinforces the links with the village, many coaches come from the village. The club has won championships and 'fair play' medals, it teaches, loyalty, commitment and fair play, no matter how good or poor they are.

The Chartered Standard needs renewing, the club has a reputation for treating children right, they always 'get a game'; weaker ones know they have less of the game and understand this.

Contribution to the village, the fete field project, £15-20K was raised by the football club, Parish Council around £15K, the balance came from grant aid, and each year the football club contributes between £1300-£1500 for the running costs.

As a Fete Field Committee they want others to use it, the brownies use the field, art and yoga groups have met in the pavilion. The field is used on Sundays, most of the day, but it is used for other things, ie. Camping, Golf, Dog Walking and as a recreation field. The Football Club managers and wives have raised most of the funds for the village, the village hall, the fun run, do the bar at the fete and so on. The football club continue to raised money for the village, a lot of teams run stalls and donate some of the money raised, to the village, Steve runs the curry stall each year.

The football club believe that the children are the future of the village, they bring a vitality to it, there are kids that are friendly and spirited, there tends to be little vandalism or graffiti etc. Children who have played in the village tend to look after the village as well, and he would urge to put funding into the kids.

Where are the tennis courts/bowing green? Steve Chapman wrote the original plan and was always going to be a Phase II, which is the Multi User Games Area, but this would have to wait until the village hall is finished. When applying for grants you have to be able to demonstrate a need, which could be done with football. The goals are left up with the football so that kids can play in the nets, there is nothing to stop them having a game of tennis. What about putting a cinder running track around, again, this would have to be a proven need to get grants.

The football club pay for the pitches on Sundays but any other time children can on the ground, it is a recreation ground. It is the most used facility in the parish, being used 50 to 100 times per year by the football club, plus dog walkers, the fete, fun run and golfers. It is one of the things that the football club is most proud of, need to tell everyone what a

good facility it is. The Parish Council would like to know what the running costs are, it was originally set up around the Section 187 grant, which allows the parish council to spend a certain amount (around £5.00) per elector. Finance of the Fete Field needs to be put on the agenda for next time.

Steve Chapman was thanked for his very enlightening report.
