218/2012.3 Knabhall Lane – fly tipping

218/2012.4 Village Entrances

It is thought that a lady who owns the land at the side of A615 from Matlock into Tansley has actually been tipping on it.

If the Parish Council could trace the owner then a letter should be sent regarding the state of this land.

219/2012 TRAFFIC ISSUES

219.2012.1 A615 Update

The VAS has been installed again, two weeks after the date given, the Parish Council need to ask for a further vehicle count now that the weather is better.

219.2012.2 Nottingham Road/Church Street-trees blocking sight lines

The trees have still not been pruned, ownership is believed to be DCC.

RESOLVED:

To write to Derbyshire County Council again.

219.2012.3 Street Nameplates – The Knoll, Church Street/Nottingham Road junction, Alders Lane/A615 junction. Carr Lane street nameplate at the top of Alders Lane is also missing.

RESOLVED:

To write again regarding the missing nameplates.

219.2012.4 Church Street Bus Shelter – damage

The repair will be completed next week. There are a couple of options open to the Parish Council regarding the offender; prosecute; ask for payment; community work. An email from a nearby resident was read out regarding the bus shelter; did this need to be repaired, they would rather the bus shelter be removed.

RESOLVED:

To ask the offender to repay the insurance excess that it will cost the Parish.

219.2012.5 Additional VAS

An additional VAS at the entrance to the village would cost in the region of £15,000, it might be possible to get this funded by 50%.

Mr Baranowski has carried out some work to the trees, and would carry out some more. The Parish Council are very grateful to him for this.

There is to be a working party this week, there will be painting and windows cleaned and a general tidy up, volunteers are wanted.
