**119.2014.1 PUBLIC SPEAKING**

A lady asked about the absence of the sign for South View, - this has been chased with DDDC and it will be erected at some point. She also asked about Sunday football parking, the other Sunday a resident had to back up four times as cars were parked on the opposite side of Church Street. The Parish Council would write to the Village Hall committee and ask if their car park could be used when not used for village hall functions. There have also been problems with parking outside of the Methodists on Fridays, recently a bus and a waste vehicle could not get through. A gentleman raised the issue of the erosion of the carriageway on Whitelea Lane. This is on the agenda later for full discussion.

**125.2014.1 Trees growing out of brook A615** –write to DCC highways, a response would be chased up.
