81.2014.1 Footpath Work – ongoing.

81.2014.2 Tawney Croft overhanging hedge – would write to householder to request the hedge is cut back.

81.2014.3 Trees growing out of brook A615 – DCC have cut the roadside verge, the drains have been blocked up and trees are growing on the outside. – would write to DCC

81.2014.4 - Possibility of listing the brook? – How do we get this listed? There could be problems related to anything that is listed.

81.2014.5 – Thatchers Lane, request for cutting back brambles – write to DCC and request that they are cut back.

There has been an excavator digging toward Thatchers Lane, onto the top of West Yard. Write to DDDC Planning and ask when the wall will be completed near the bund area.

81.2014.6 Spout Lane, cut back and removal of self sets – the clerk would ask the contractor to remove the self sets, and also weed the planted area on the Village Green, also the steps. The phone box area, bus shelters and planters all need weeding around. – the clerk would arrange for this.
