35/2020 PUBLIC PARTICIPATION

35.2020.1 PUBLIC SPEAKING

Hardyal Dhindsa; Derbyshire Police and Crime Commissioner, attended the meeting as part of his objective to visit all parts of Derbyshire before the end of his term. He spoke about his 7 Strategic Objectives, his Role and Responsibilities, the Police & Crime Plan, The Derbyshire Alert system is being set up again. There has been a reduction in Officers in Derbyshire from 2126 in 2010 down to 1702 in 2017, this will be increased this year by 58 Police Officers' and 62 Police Staff positions. Derbyshire Dales will benefit from this by 7 personnel. He spoke about the work he has been doing over the last few years and where he wishes to be when he steps down from his post next year. He also took questions from the meeting.

There are concerns about the flooring in the hall, as it has been repaired, it may require overboarding, as there are some safety concerns for users.

39.2020.3 Planning Issues

A615 Woodyard Parking Area – non compliance with planning permission

This matter was discussed, as some parish councillors have concerns that the extended car parking area does not comply with the planning conditions, i.e. boundary walls, making it difficult to be able to site a crossing point, as vehicles can cross into the car park at any point.

RESOLVED: to write to DDDC to request that they enforce the conditions.

40.2020.1 Footpath Update

40.2020.2 Childrens Play Area Village Green – meeting with Kompan

Cllrs Strange & Taylor had met with Kompan and they are going to provide a quotation on more or less like for like with Playdale, however, they felt that the swings could be refurbished. Cllr Neville has also spoken to a provider Huck Ltd, and they will also be able to provide a quotation.

The funds from the Tansley Development Association should also be forthcoming towards the play area project.

40.2020.3 Village Green New Signage

There has been no response to our questions, so will contact the Chief Exec, to pursue this matter. The sign is dangerous and unwanted, DDDCllrs are also challenging the fact that there has been no consultation regarding this signage.

40.2020.4 DDDC Village Maintenance Schedules –flail mowing as not yet taken place.

RESOLVED: to request information from DCC Highways section regarding schedules.

40.2020.5 The Pinfold/Heathy Lea – ownership of the Pinfold is moving forward. Cllr Flitter suggested writing to Mike Galsworth via Paul Wilson to pursue Heathy Lea and any outstanding deeds for the community hall.

40.2020.6 Hanging Baskets – comments have been received regarding the mix of plants and the maturity of the plants in the hanging baskets. The Parish Council did not actually receive their allocated baskets due to DCC changing the lighting columns.

RESOLVED- the clerk would contact the contractor to see if anything can be done or any reimbursement, and would also contact Belper Town Council & Tupton to find out who is their contractor.

Derbyshire County Council are happy for a planting scheme, i.e. wildflowers, but will not fund anything, and they will require a plan of what we intend to do for their consideration.

RESOLVED: Cllr Taylor would illustrate a plan for their consideration.
