90.2025.1 Planning Applications:

90.2025.3 Planning

DDDC – call for sites, biodiversity sites within communities.

DDDC are currently consulting on sites for development of all kinds, and are also looking at land Biodiversity Net Gain, Derbyshire Wildlife Trust are running the Biodiversity Credits scheme. The Council could consider Knabb Hall, which may not attract many credits, as it taken over to wildlife already, but Heathy Lea could possibly be considered. The consultation ends on 20 December 2024.

91/2025 ENVIRONMENTAL ISSUES

91.2025.1 Overhanging trees footpath 4 behind Tawny Croft and adjacent to Stancliffe development, contact residents.

Trees are coming onto the footpath from the private garden onto the path.

RESOLVED: To write to a number of householders separately about overhanging vegetation.

91.2025.1 Plaques from the village green detailing the children born in the millennium year.

There are two plaques detailing the children born in the millenium year, these used to be placed on two trees, which have since died.

RESOLVED: To attach them to railings on the village green.

92/2025 HIGHWAYS ISSUES

92.2025.1 OVERHANGING VEGETATION ONTO THE FOOTWAYS

There seems to be a lot of hanging vegetation on the footways causing pedestrian to sometimes have to walk in the highway or very close to it.

RESOLVED: That the properties highlighted would be written to separately, and DCC would be notified of the trees coming through the wall on Nottingham Road.

92.2025.2 Vehicle Activated Signs within the village

RESOLVED: To write to DCC and report this sign not working again.

93/2025 FETE FIELD

93.2025.1 Metal Storage cabinet/cleaners store.

Cllr Taylor reported that the cleaner has nowhere to store the cleaning materials, which goes again COSH (control of substances hazardous to health) regulations. He has been able to source a suitable cabinet £171.99 + vat; which comes flat packed and he will assemble and install.

RESOLVED: to buy the cabinet and get it on site, and also ask if the FFC will reimburse the cost. (7 in favour, 1 abstention)

93.2025.2 Survey of Pavilion re: maintenance plan

A while ago the FFC were to undertake a survey of the pavilion to put together a future maintenance plan, as yet this has not happened. Cllrs Flint & Taylor are happy to go around the building and see what work is required, and report back to the Parish Council to see where the responsibility for the work lies.

RESOLVED: that Clirs Flint and Taylor carry out a survey and report back to the PC.

93.2025.3 Drainage Issue – feedback

Cllrs Flint & Taylor have been to the fete field, all the growth has been cut back. They walked all of the field and could not find any soft spots, the field should drain to the Rope Walk. They are unable to locate the drawings for the herringbone drains across the field. The new shed may cause a problems with its foundations. It seems that the water is coming from the new development. Cllr Strange informed the meeting that there are two pipes going up the field, a few years ago UK Drainage put a camera in the pipes, it would appear that stone has got into the pipes from the soakaway. There is a pile of rubble at the edge of the field which may be covering a manhole which may give some clues.

RESOLVED: To ask for a figure to clear and remove the rubble which may enable to determine if there is a manhole.

93.2025.4 Replacement of two fruit trees

RESOLVED: To replace the two dead fruit trees when appropriate.

Cllr Longworth who is the Treasurer of the FFC gave a short verbal report to the Council on the running of the finances.

'the financial year is now January to December, and a position reported to each FFC meeting, they are looking to use online banking in the future. There is a proper booking system in place now, and all money received has an invoice, there are no cash payments. He is hoping to put together budget projections also'.
